4. Not to use or authorize others to use these items for any purpose differing from the specific stated use, without written permission from the Local History Archives.
5. To provide to the Archives, 1 free copy of the item containing the visual material that is produced or published.
6. The Archives does not sell duplications but rather performs the service of reproduction for which a fee is paid.
7. The reproduction of any book, manuscript, or other material in a collection of the Archives in its entirety is prohibited, unless for preservation purposes.
8. The Archives reserves the right to limit the number of photographic copies; to restrict the use of reproduction of rare or valuable items; to ensure the use of material from its files is reproduced in good taste; to make special fee quotations on items involving unusual difficulty in copying; and to charge a higher fee than specified for unique items.
